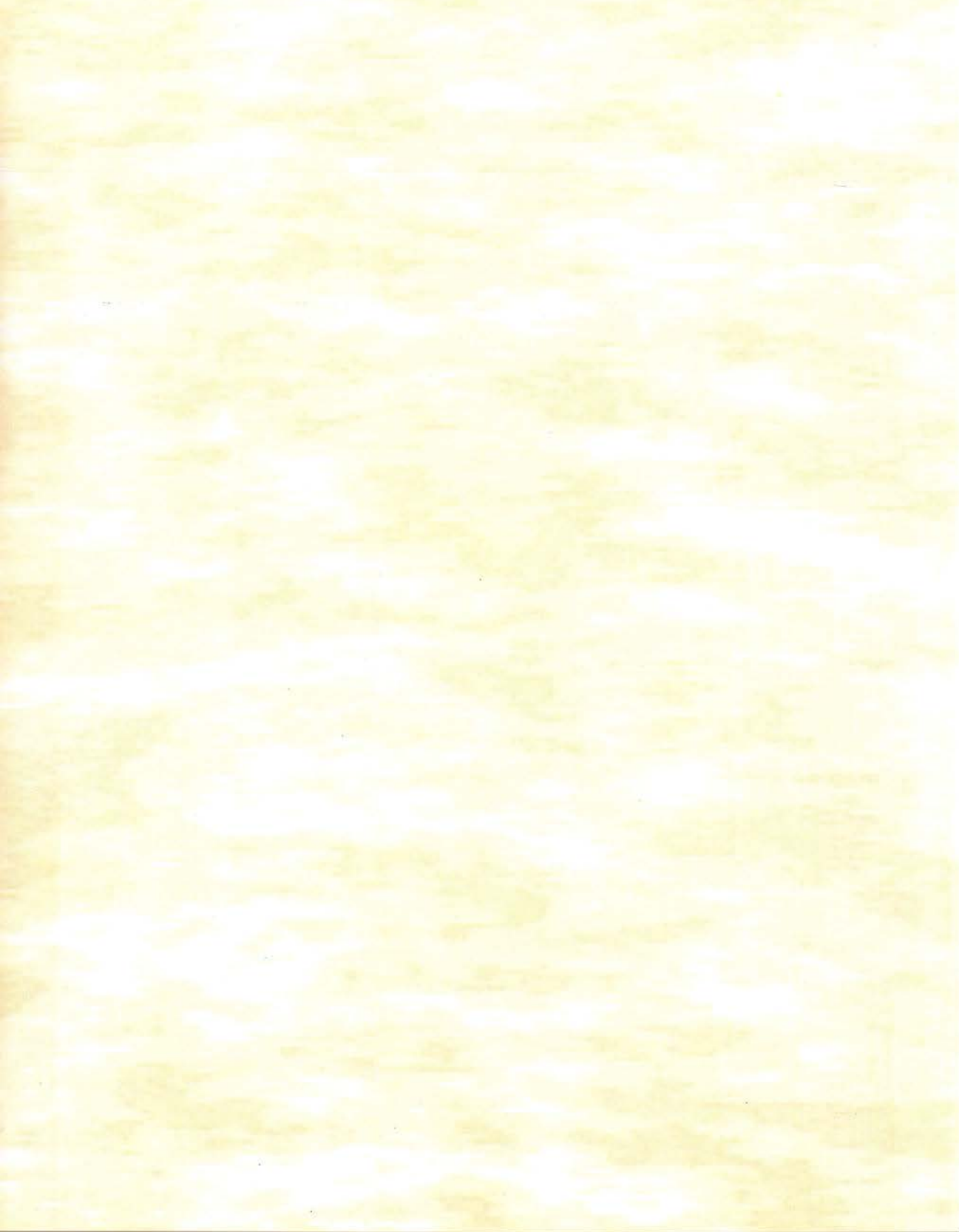

MANDATE

The Indian Agricultural Universities Association is a Registered Society under Registration no. 3498 of 10 November, 1967. It was established in November 1967 with nine agricultural universities as its founder members, viz. PAU, Chandigarh (now Ludhiana); APAU (now ANGRAU), Hyderabad; JNKVV, Jabalpur; UPAU (now GBPUAT) Pantnagar; UAS, Bangalore; KU, Kalyani (now BCKV, Mohanpur); OAUT Bhubaneswar; UU (now MPUAT, Udaipur) and IARI, New Delhi.

During this long span there has been phenomenal increase in the number of member universities, especially during the late 90s and onwards. At present the strength of association membership is 47 agricultural universities, i.e. 40 state agricultural universities, 5 deemed-to-be universities (AAI, IARI, CIFE, IVRI and NDRI) and 2 central agricultural universities (CAU, Imphal and BHU). All these are regular members of the Association.

The main objective of the Association is to promote agricultural research, education and extension in the universities and states, and thereby rural development in the country. It also acts as a bureau of information to facilitate communication, co-ordination and mutual consultation among agricultural universities. The Association also acts as a liaison between member universities and government departments to facilitate communication and expedite the needed action in matters of importance.

All the universities and institutions (deemed-to-be universities) in India, which provide an integrated programme of teaching, research and extension education in agricultural sciences, are qualified to become regular members of the Association.

Vice-Chancellors of member universities or institutions constitute the Association's General Body. The General Body meets once a year to decide the agenda for the next convention and also for adoption of its audited accounts of the year and approval of budget estimates for the next financial year, besides the election of the office-bearers for the following calendar year. The Executive Committee of the Association consists of President, Vice-President, Secretary-Treasurer and three members. The Executive Committee meets quarterly.

The office of the Association is manned by Executive Secretary, who implements the decisions of General Body and Executive Committee on behalf of the Association. A quarterly newsletter is also being published by the Association since 2000, giving important news, events and achievements by member universities for the information of all the members.

The main source of revenue of the Association is the annual subscription from member universities. The ICAR also provides a nominal grant annually.

MANAGEMENT

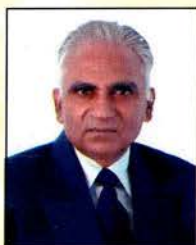

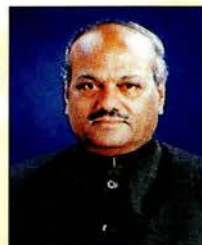

Four **Executive Committee Meetings** were held during the year viz No. 2 of 2007 on 29 June' 2007, No. 3 of 2007 on 19 November' 2007, No. 4 of 2007 on 19 December' 2007 and No. 1 of 2008 on 7 March' 2008.

The major resolutions of the meetings are:-

1. To request D.G. ICAR for reduction in training fee by NAARM, Hyderabad for S.A.U. Trainees.
2. To strengthen farmer-Scientist linkage in KVKS.
3. To request D.G. ICAR to advise Director, NAARM to develop short-term orientation programme on teaching methodologies for newly inducted teaching faculties.
4. To request ICAR to provide financial assistance to S.A.U.s to start 'Distance Education'.



5. To hold 3rd Brainstorming session on 'Agricultural Education policy' at PAU Ludhiana in March' 2008.
6. To call 4 to 5 technological excellence of the universities.
7. To recommend AIRCPs to ICAR on cucurbits; Rabbit at LRS; Turkey at PRS; Saffron production in hilly region; Protected farming and Food for health.
8. To ask for S.A.Us Research Journals and send them to NAAS for categorized grading.
9. To write to chief secretaries of the States and also to Development Commissioners to employ Home Science graduates in the state development projects and programmes.
10. To write to VIth pay commission and chairman, U.G.C. to consider the posts of Deans/Directors as promotional posts.

General Body Meeting

The **General Body Meeting** was held on 21 December 2007 at B.A.U. Ranchi.

The meeting was chaired by Dr. M.P. Yadav, past President and VC. SVBPUA&T. Meerut. It was attended by 17 Vice-Chancellor / Directors and 9 Representatives.

The major Resolutions of the meeting are: -

1. Election of new Executive Committee for the year 2008.
2. 33rd Annual Convention in December 2008 at AAU, Anand.
3. 5th National Symposium in September 2008 at AAI. Allahabad.
4. Seniority of the VCs/Directors to be based on actual period during which one served as regular VC, irrespective of any gap period.
5. President to write to state Governors and C.Ms where the VCs's tenure is less than 5 years, to raise it to 5 years for maintaining uniformity.
6. President to write to State Governors and C.Ms to raise the retirement age of VCs from present 65 years to 70 years.
7. Ratification of the induction of GADV&ASU., Ludhiana as IAUA's 47th member.
8. Adoption of audited accounts of the Association for the year 2006-07.
9. Approval of the Secretarial budget for the year 2007-08.

EVENTS

4th National Symposium

The 4th National Symposium on '**Recent Trends in Organic Farming**' was held on 11-12 September 2007 at M.P.K.V. Rahuri.

The major Recommendations that emerged are:-

- ◆ Schedules of practices to be followed for different models for organic farming be prepared on agro-ecological regions for different components so as to conserve the soil, water and



environment.

- ◆ Policies on certification of organic products with costs etc. be formulated at par with that of International standards.
- ◆ Packages be developed to ensure proper nutrition to crops/live stock and other components by utilizing organic residues from farm, animal sheds, rural/urban/industrial waste etc.
- ◆ Use of high value low volume crops like: vegetable flowers, fruits, tea, coffee etc be encouraged with the use of transgenics for organic farming.
- ◆ There should not be any dependence on chemical fertilizers, herbicides, fungi and pesticides use in any component of farming systems. Alternative indigenous practices based on organics, efficient cultural practices be thoroughly perfected for each component of farming system.
- ◆ A separate all together different strategy is needed for the use of transgenic crops containing pest resistant genes, in organic farming.
- ◆ The rainfed and hilly regions provide better opportunity for organic farming due to least use of chemical inputs.
- ◆ The whole farm residue from crops, animals, sugar factories, vegetable markets and organic urban waste be put under microbial decomposition to be converted into nutrient rich organic manures.
- ◆ Government should provide subsidy to the user of bio-agents and bio-pesticides to promote their use.
- ◆ There should be separate premium in marketing policy for the organic produce/products to encourage organic farming.
- ◆ Organic dairy farming has a good scope in our country being small holders using low inputs, mostly crops residue based production system contributing 70% of total milk production.
- ◆ There is a big potential to change conventional farming to organic farming through dairy farming at a faster pace by efficiently utilizing the animal wastes.
- ◆ In order to tap organic milk produced in interior rural areas the distinct cooperative system needs to be established, with public-private and farming community partnership for procurement, certifying, processing and marketing of organic milk.
- ◆ Screening of efficient microbial cultures to work in varied temperature conditions and their commercial use will prove an asset to the organic farming.
- ◆ There is a need to develop organic farming standard/norms at state level and also accredited the accreditation agencies for indigenous and export marketing to put a check on adulterated/ spurious products.
- ◆ Agricultural universities need to be recognized as certifying agency for organic farming produce and its products.

32nd Annual Convention

The 32nd Annual Convention of VCs on '**Diversification in India Agriculture**' was held on December 20-21, 2007 at Birsa Agricultural University, Ranchi.

The major recommendations are:-

- ◆ Massive education programme backed by infrastructure and policy support is needed to change mindset of farmers to produce more, through farming systems.
- ◆ Series of network projects for high-tech agriculture at micro level needed to increase productivity of main market-led crops.
- ◆ On farm training of scientist and farmers with the involvement of public-private partnership is needed for diversification in agriculture.
- ◆ Organic farming research areas be demarcated for the best utilization of suitable crops available in different soil and climate conditions.



- ◆ Certification of organic agricultural produce be organized through referral laboratories established at the A.U.s in collaboration with state line departments; to facilitate timely proper marketing.
- ◆ Apiculture, floriculture, horticulture, vegetable production Agro-forestry, mushroom, fish and various live stocks as per the different climate offer tremendous potential for diversification in farming.
- ◆ Special emphasis be given for the crops/live stocks of export potential with the chain of value addition and quality assurance through marketing intelligence and established norms.
- ◆ Contract farming on selected high value crops/live stocks through mechanization is highly desired for diversification in farming with the support of timely inputs supply.
- ◆ Various location specific farming system perspective models be establish and popularized for higher and quality production.
- ◆ Emphasis on new applied areas of research i.e. crops modeling, nano-technology, climate change and pollution-effect on farming be given priority for diversification.
- ◆ Diversification in agriculture should lead to more economic production, employment opportunities, recycling of organic crops/animal waste and to conserve the natural resource.

3rd Brainstorming Session

The 3rd Brainstorming Session on '**Agricultural Education Policy**' was held on 8-9 March' 2008 at Punjab Agricultural University, Ludhiana.

The major recommendations are:-

- ◆ There is an absolute need to introduce agricultural education right from the school level upward culminating into vocational courses with particular emphasis on deliverables in each course.
- ◆ The states may be encouraged to set up 'Board of Higher Education' in agriculture for improving the quality of education.
- ◆ SAUs should make efforts to enhance influx of students from rural areas in agricultural programmes. Reservation of seats for such students in agriculture education through legislation may be an answer to it.
- ◆ Admission to agricultural programmes in all the private/public institutions should be through common entrance test.
- ◆ There is a need to reconsider monitoring of teaching quality, evaluation and to re-visit the internal evaluation as existed earlier than shifting to external evaluation.
- ◆ Course curriculum should be made demand-driven to prepare students, to face the newly emerging challenges, and lay due emphasis on practicals.
- ◆ SAUs should have more diverse range of relevant courses which the students can choose VIZ, Biotechnology, Nanotechnology, Information and Communication Technology, Space, IPR, WTO, Agri-business etc.
- ◆ For the sake of quality education, thrust should be given on Human Resource Development (HRD) in cutting edge technology areas as it used to be in the 1970s.No post should be kept vacant.
- ◆ There is a need to establish relation/collaboration with traditional universities, IITs, IISc., IIMs and industry for perfect wide range updated education.
- ◆ There should also be a separate fisheries, live stock and animal husbandry education policy integrating education, research and extension.
- ◆ Accreditation process needs to be speeded up and extended to private agricultural colleges. Simultaneously AUs should be equipped to handle the affiliation of private agricultural colleges to keep up the academic standards.
- ◆ Evaluation system should be combination of both external and internal with 50 % weight-



age given to each. As this is recently recommended, it may be reviewed after gap of some period.

- ♦ There is a great need of open door policy to encourage students and teachers from basic sciences to join AUs and basic sciences students be admitted to agricultural PG courses.

FINANCE, BUDGET AND AUDIT

The main source of revenue of the Association is the subscription from member universities. In addition, the ICAR which used to provide a nominal assistance of Rs 3 lakhs annually for organizing national level events like Annual Conventions, National Symposiums and Brainstorming sessions etc. has now increased it to Rs 4.00 lakhs w.e.f. 2007-08. Efforts are being made to convince ICAR to raise the annual assistance from the present Rs 4 lakhs to Rs 10 lakhs, to enable the Association to expand and organize its activities in a proper perspective manner.

The audited Statement of account for the year 2007-08 is given in Annexure 1. It shows that total income of the association from annual membership subscription is Rs 18,80,000 (Eighteen lakhs eighty thousand) and total expenditure as Rs 16,39,628.25 (Rs Sixteen lakhs thirty nine thousand and six hundred twenty eight and Paise twenty five). At the close of the financial year 2007-08, the Association has a fixed deposits of Rs. 63, 90,476/- (Rs. Sixty three lakhs ninety thousand four hundred and seventy six).
